AIRCRAFT MARKETING AUTHORIZATION (An Exclusive Right to Sell)

This is to certify that _____ is the registered owner of the following aircraft:

FAA Reg. # _____ and that this aircraft is available for immediate sale at a price of \$ _____.

I hereby authorize Skywagons.com, LLC and its agents to procure a buyer for subject aircraft.

If Skywagons.com, LLC (its owners, employees, agents, or cooperative brokers) introduces me to a buyer - whose offer to purchase, lease or rent said aircraft I accept, then I agree to pay Skywagons.com, LLC a Finders Fee equal to 8% of the total value of the Purchase/Lease/Rental Agreement in addition to the costs associated with procuring said buyer.

I retain the right to use other means available to me to procure a buyer for this aircraft. If I produce a buyer independent of the efforts of Skywagons.com, LLC, then a Finders Fee to Skywagons.com, LLC shall be 8% of the listed selling price in this agreement in addition to any costs incurred by Skywagons.com, LLC in connection with the attempt to procure a buyer.

I agree to pay Skywagons.com, LLC a minimum advance payment of \$500.00 against advertising costs, ferrying costs, reconditioning costs, detailing costs, and/or any other costs that may be incurred in connection with the attempt to procure a buyer. The aircraft may incur costs which exceed the \$500.00 advance payment on account. I agree to pay additional advance payments to Skywagons.com, LLC that may be required from time to time as costs incur, in order to maintain a \$500.00 balance. Upon the sale of the aircraft, Skywagons.com, LLC shall have no longer than 30 days from the date of sale to return any remaining funds from this "advance payment account" to ensure that all fees and costs incurred by Skywagons.com, LLC have been accounted for.

Any and all fees and reimbursement of additional costs above and beyond the advance payment(s) shall be paid directly to Skywagons.com, LLC out of the proceeds of the final sale prior to seller receiving the balance of the agreed upon value. Seller to receive balance of funds due no later than three working days after physical delivery of the aircraft to the buyer. Up to \$500.00 in additional funds may be retained by Skywagons.com, LLC for a period of no longer than two weeks to pay for outstanding bills (i.e., advertising, etc.) that may not have yet been posted. If I default on my promise to pay the Finders Fee or reimbursement of costs, then I agree to pay the attorney's fees, court costs and any other expenses incurred by Skywagons.com, LLC in the collection of said fees.

I agree to maintain liability and hull insurance on said aircraft until said aircraft is sold.

I agree to completely and fully indemnify, defend, and hold harmless, Skywagons.com, LLC from any and all claims, losses, costs, expenses, obligations, liabilities or debts, including, but not limited to, clear title, damage history, corrosion, airworthiness, cosmetic condition, missing logbooks, etc.

Any controversy involving the construction or application of any of the terms, provisions or conditions of this guarantee, shall, on the written request of either party served on the other, be submitted to binding arbitration without the right to a trial de novo, subject to the California rules of Court and the Local rules of the

El Dorado County Superior Court relating to judicial arbitration. The cost of arbitration shall be borne by the losing party or in such proportions as the arbitrator shall decide.

This Agreement shall be construed in accordance with the laws of the State of California. Any legal action or any arbitration or other proceeding brought for the enforcement of this agreement shall be brought in the State of California, County of El Dorado.

All of the terms, covenants and conditions herein contained shall be for and shall inure to the benefit of and shall bind the respective parties hereto and their successors and assigns, respectively.

If any legal action or any arbitration or other proceeding is brought for the enforcement of this guarantee, or because of an alleged dispute, breach, default, or misrepresentation in connection with any of the provisions of this guarantee, the successful or prevailing party or parties shall be entitled to recover reasonable attorneys' fees and other costs incurred in that action or proceeding, in addition to any other relief to which it or they may be entitled.

This authorization may be cancelled by either party with written notice to Skywagons.com, LLC at 3501 Airport Road, Bldg. #2, Placerville, CA 95667 by Selling Authority, or to Selling Authority at address listed below by Skywagons.com, LLC. My promise to pay a Finders Fee shall remain in effect for 90 days after cancellation of this authorization.

It is further agreed that this Aircraft Marketing Authorization is the only contract controlling this "exclusive right to sell" and that it contains all agreements, expressed or implied, either verbal or in writing, and I acknowledge receipt of a copy of the same.
